

after effecting power supply to the point. A plan showing S/S, line to be approved before execution of work.

- ***Before commissioning of the line & Sub-station, it should be inspected by the Deputy Electrical Inspector, Rourkela proof of purchasing the required materials for the work have to be submitted to this office for verification prior to erection. The Transformer must be inspected at your cost by the WESCO authorities before installation of the same conforming to BIS specification. Other materials should also be inspected before use.***

1. The Offerer should be a license Electrical Contractor from appropriate authority.
2. The Offerer will get the line and sub-station inspected by Dy.Electrical Inspector, Rourkela.
3. The Transformer must be inspected at Offerer's cost by the WESCO authorities before installation of the same confirming to 3 Star rated Transformer with BIS specification. Other materials should also be inspected before use.
4. From the Transformer up-to meter, LT cable is to be provided and one whole current meter of appropriate capacity shall be installed in suitable WESCO approved TP box to record the consumption at the entrance gate of the consumer's premises. The cost of which shall be deposited by you with the Executive Engineer, J.E.D, Jharsuguda under deposit work norm before execution of agreement.
All rules, regulations, norms & conditions of WESCO as approved by OERC Distribution (Condition of Supply) Code 2004 should be fulfilled before effecting power supply by the offerer.
10. Interested Manufacturer/Supplier/Distributor may quote their rate indicating price, Tax,, Terms of Rate, Guarantee etc to the above address. **The detail technical specification, features of the Goods should be clearly mentioned in the quotation.** Boucher/Leaflet of the goods be attached with the quotation.
11. The Party should attached past experience if any.
12. The Party should attached valid license copy, PAN Card, GST No. and other statutory documents with the offer.
13. GST Extra for the taxable Item.
14. Quotation should remain valid for a period not less than **60 days** after the deadline date specified for submission.
15. Quotation should conform to the terms and conditions, and specifications.
16. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject any or all quotations at any time prior to the award of contract.
17. Payment shall be made within 30 days of installation and commission of all work and submission of all documents from WESCO and Electrical Inspector.
