**Service cable meter Where ISI certification marked goods are available in market, purchase should generally be limited to goods with those or equivalent marking only.*

- **Before commissioning of the line & Sub-station, it should be inspected by the Deputy Electrical Inspector, Deogarh proof of purchasing the required materials for the work have to be submitted to this office for verification prior to erection. Other materials should also be inspected before use.**
1. The Offerer should be a license Electrical Contractor from appropriate authority. The copy of license will be alongwith tender paper.
 2. The Offerer will get the line and sub-station inspected by Electrical Inspector, Deogarh.
 3. The Offerer is to be ensured that no over head line of TPWODL is passing though the premises. In case any existing line is there, it is to be shifted to outside the premises of the Party, before supplying load, the cost of which is to be borne by the applicant.
 4. LT cable of suitable capacity is to be provided and one LTCT meter will be installed in a suitable TPWODL approved TP box. The cost of which shall be deposited under deposit work norms before execution of the agreement.
 5. **The Offerer will submit inspection report and other report and material purchase bill invoice copies and guaranty certificate to Samaleswari Milk Union. Only after submission of this report liaising charges shall be released to the Party.**
 6. Suitable capacity cable is to be provided up to the meter. To record the consumption one LT CT meter of appropriate capacity shall be installed near the sub-station in the TPWODL approved TP box. The cost of which shall be deposited with the Executive Engineer, TPWODL, Deogarh, under deposit work norm before execution of agreement. **All rules, regulations, norms & conditions of TPWODL as approved by OERC Distribution (Condition of Supply) Code 2004 should be fulfilled before effecting power supply by the offerer.**
 7. Interested Contractor/Manufacturer/Supplier/Distributor may quote their rate indicating price, Tax,, Terms of Rate, Guarantee etc to the above address. **The detail technical specification, features of the Goods should be clearly mentioned in the quotation.** Boucher/Leaflet of the goods be attached with the quotation.
 8. The Party should attached his Past experience, if any.
 9. The Party should attached PAN CARD, GST NO. and other statutory documents with the offer.
 10. GST Extra as applicable.
 11. Quotation should remain valid for a period not less than **30 days** after the deadline date specified for submission.
 12. Quotation should conform to the terms and conditions, and specifications.
