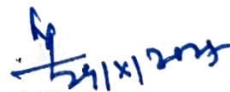

Expression of Interest(EOI) for Participating in the Supply of 100 nos. of Milch cows with female calves under Schemes of SAMALESWARI REGIONAL COOPERATIVE MILK PRODUCERS' UNION LTD, Boudiapada, Kalamati, Sambalpur

1. **Objectives:**

1. With the objective of augmenting milk production in the district and providing rich source of protein to its citizens of the district for a healthy tomorrow, and the same time provide sustainable livelihood to dedicated entrepreneurs, the District Administration, Sambalpur through the SAMALESWARI REGIONAL COOPERATIVE MILK PRODUCERS' UNION LTD intends to livelihood support to the dairy farmers.
2. The Scheme has been formulated keeping in mind certain assumptions:
 - a. That for several years the SAMALESWARI REGIONAL COOPERATIVE MILK PRODUCERS' UNION LTD has supported farmers in the form of subsidy whether in Dairy, but the overall impact has not yielded much results which can be seen from the Livestock Census. The per capita availability of milk per person per day in the State is only 144 gm., where as the National average is above 471 gm.. This indicates the low production and low consumption of milk.
 - b. That even though farmers are now aware of the potential of dairying, yet the courage to venture into this activity is not there due to lack of financial resources etc. Subsidy scheme given by the Department is too small to met the actual investment for setting up a sustainable unit of Dairy.
 - c. That even though **Sambalpur** has been making relative progress in small business enterprises, yet many of the educated youth is still lingering in search of resourceful and gainful enterprises, of which dairying is one such avocation.
 - d. That the **White revolution** which started in State like Gujarat has changed the economy of the State significantly, there is tremendous believe that the district of Sambalpur which has a congenial weather suitable for a high yielding variety of **Cross breed Jersey** should one day become the centre of potential for Dairy Industry.
 - e. That there is an immediate and urgent imperative now to motivate , encourage and attract young and enthusiastic entrepreneurs to take up Dairy farming in a moe sustainable way.

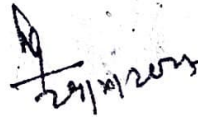
- f. Virtually every aspect of dairy cattle performance is controlled by genetics milk , fat, protein yield, reproduction, feed efficiency, length of life in the herd, calving ability and the ability to resist diseases such as mastitis – are all linked to unique genetic make-up. Thus the aim of the programme would be to have organized animal breeding services to cover this breedable population of cattle by extending and institutionalizing door-step Artificial insemination(AI) services so that the livestock can have faster genetic gain, better milk production on an economically sustainable basis.
3. The scheme has been formulated keeping the following objectives in min:
- (a) To develop Dairy Farming as an economic activity in remote areas in the district of Sambalpur.
 - (b) To encourage and increase women stake holder investment participation in the whole value chain and production process of Dairy.
 - (c) To encourage and facilitate sustainable models of production.
 - (d) To encourage and mobilize farmers' stakes as partners in the same process such that a sense of ownership is instilled amongst the farming community leading to better ownership responsibility and accelerating the adoption of technology, financial discipline and quality control culminating in improved and sustainable economic returns.
 - (e) To develop and strengthen the risk taking ability of the farming community through a combination of technology, assured markets, credit linkages and institutional support.
 - (f) To enable the frming community to capture opportunities generated by the new climate of market oriented production and value chain approach.
 - (g) Given the importance of genetics in the animals in the herd, it is important to manage genetic change and improvement . to provide Veterinary services and extension services for genetic improvement of the cattle for promotion of healthy and more productive cow/ animal.

2. **BROAD SCOPE OF WORK:**

- i. Bidder's scope of work and supply shall comprise supply of 100 nos. of Milch cows with female calves as per specification supported by a declaration certificate from a registered veterinary practitioner or genetic character of each cow, breed, age, milk yield per day recorded for a minimum period of 3 days and duly authenticated.
- ii. To also support with detail health status, vaccination record, last calving date etc duly certified by a registered Veterinary Practitioner.
- iii. The cows to be supplied should have valid insurance cover for not less than 2 (two) years on the date of supply.
- iv. Bidder should declare the number of cows available at their possession with detail history as mentioned in (i) above.

3. **ELIGIBILITY CRITERIA:**

Bidder intending to bid shall fulfil the following eligibility criteria:

- a. Shall be Institution/ firm/Farms/registered Dairy society etc. Preference shall be given to those who have got a tie-up with sexed semen supplier/ providers.
- b. Should have proven financial services capability, particularly in financing programmes/ projects.

- iii. Milk Yield should not be less than 15(fifteen) litres to be verified by the technical team appointed by Department of animal Husbandry and Veterinary for a certain period of times to the satisfaction of the Department.
- iv. All the laws related to transport etc. should be followed as per the guidelines of Govt. Of Odisha.
- v. The animals will be maintained in closed observation for seven days & if any abnormality in milk production (-1 ltrs. to +1 ltrs. acceptance) or any disease conditions are detected, the supplier will replace such animals from the beneficiaries premises at his own cost by same quality.
- vi. In case of any death of animal, the farmer will get the same standard animal from the selected bidder out of the insurance claim amount.

10. **Award Criteria:**

- i. The Financial bids for milch cows with female calves will be finalized based on the cost quoted per litre of milk (including transportation **at farmers site & insurance price**). The bids for supply of 100 nos. of milch cows & female calves will be finalized based on the price per animal(including transportation **at farmers site & insurance price**).
